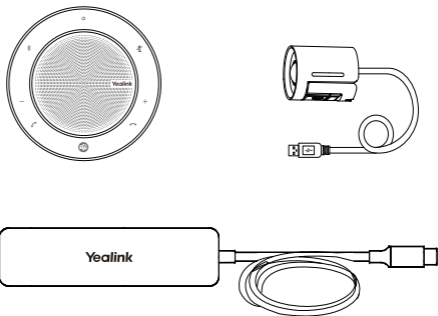

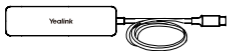

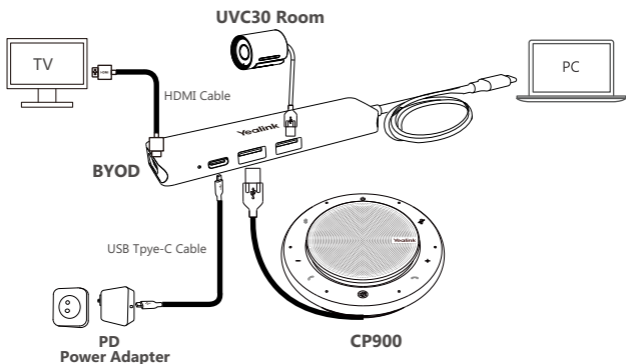

# Connecting Your Devices with BYOD



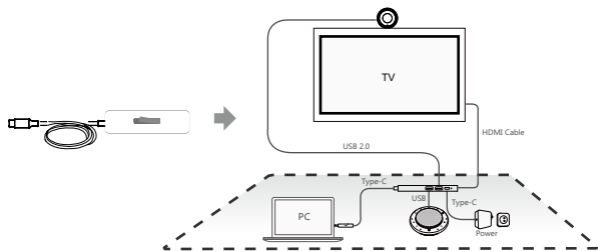
💡 We recommend that you use a stable 1.8m HDMI cable with magnetic ring to connect the TV.

## Placing Your Devices

Yealink UVC30-CP900-BYOD Meeting kit is suitable for focus and small rooms with 2-7 participants.

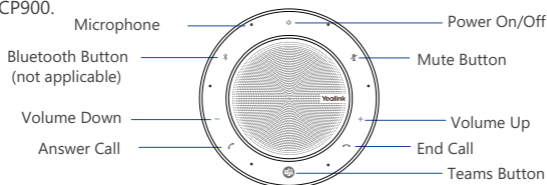
Place the CP900 on the center of the table, up to 2m/6.5ft from each participant.










Attach the BYOD box to the bottom or the top of the table.



# Using Your CP900



The CP900 is compatible with Microsoft Teams/Skype for Business client, Zoom client and so on. After connected, you can control the calls on the CP900.



Task	Do
Power on or off	Hold  for 2 seconds.
Answer a call	Tap  .
End or reject a call	Tap  .
Volume up/down	Tap  /  .
Mute/unmute microphone	During a call, tap  . The mute LED Indicator and LED light-ring glow red.
Hold a call	During a call, tap  . The LED light-ring flashes green.
Reset to the factory	Hold  and  for 6 seconds.

## Teams Button Functions

The Teams button is only applicable when connected to Microsoft Teams client.

Task	Do
Activate Cortana/Activate your smartphone's voice assistant	Hold  for 2 seconds.
Invoke the Teams client	After the Teams client connects, tap  .
